ATT sabiex jemenda l-Ordinanza dwar l-Esplożivi, Kap. 33

IL-PRESIDENT bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, hareġ b'liġi dan li ġej:-

**A BILL
entitled**

AN ACT to amend the Explosives Ordinance, Cap. 33.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title. **1.** The short title of this Act is the Explosives Ordinance (Amendment), 2019, and this Act shall be read and construed as one with the Explosives Ordinance, hereinafter referred to as "the principal Ordinance".

4 of the

Ordinance.

2. In article 4(b) of the principal Ordinance the word "conductor;" shall be substituted by the word "conductor:" and immediately after there shall be added the following new proviso:

"Provided that no such wall or any other solid fence shall be required for fireworks factories;"

Objects and Reasons

The objects and reasons of this Bill are to waive the requirement for a high fence in respect of fireworks factories but not other explosives factories.
