ATT biex jemenda l-Att dwar il-Pulizija, Kap. 164.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, hareġ b'liġi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att huwa l-Att tal-2019 li jemenda l-Att dwar il-Pulizija, u għandu jinqara u jinftiehem haġa waħda mal-Att dwar il-Pulizija, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

Titolu fil-qosor.
Kap. 164.

2. L-artikolu 36 tal-Att prinċipali għandu jiġi emendat kif ġej:

Emenda tal-artikolu 36 tal-Att prinċipali.

(a) is-subartikolu (1) tiegħu għandu jiġi emendat kif ġej:

(i) il-paragrafu (h) tiegħu għandu jiġi mhassar; u

(ii) il-paragrafi (i) u (j) tiegħu għandhom jiġu enumerati mill-ġdid bhala l-paragrafi (h) u (i) rispettivament;

(b) is-subartikolu (6) tiegħu għandu jiġi mhassar; u

(c) s-subartikolu (7) għandu jiġi enumerat mill-ġdid bhala s-subartikolu (6).

Għanijiet u Raġunijiet

L-għanijiet u r-raġunijiet ta' dan l-Abbozz huma sabiex jitneħħew id-dispożizzjonijiet b'rabta mal-appelli peress li l-Bord Indipendenti dwar l-Ilmenti tal-Pulizija ma għandux il-*vires* meħtieġ sabiex jisma' l-appelli mid-deċiżjonijiet tal-bord dixxiplinari.

AN ACT to amend the Police Act, Cap 164.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.
Cap. 164.

1. The short title of this Act is the Police (Amendment) Act, 2019 and this Act shall be read and construed as one with the Police Act, hereinafter referred to as "the principal Act".

Amendment of
article 36 of the
principal Act.

2. Article 36 of the principal Act shall be amended as follows:

(a) Sub-article (1) thereof shall be amended as follows:

(i) paragraph (h) thereof shall be deleted; and

(ii) paragraphs (i) and (j) thereof shall be renumbered as paragraphs (h) and (i) respectively;

(b) sub-article (6) thereof shall be deleted; and

(c) sub-article (7) thereof shall be renumbered as sub-article (6).

Objects and Reasons

The objects and reasons of this Bill is to remove the provisions in relation to appeals as the Independent Police Complaints Board does not have the necessary vires to hear appeals from the decisions of the disciplinary board.
