Bill No ___ of 2020

A Bill entitled an Act to amend the Notarial Profession and Notarial Archives Act, Chapter 55 of the Laws of Malta

Be it enacted by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title The short title of this Act is the Notarial Profession and Notarial Archives (Amendment) Act hereinafter referred to as the "Principal Act".

Revocation of Proviso to Article 28(1)(c)(i) of the Principal Act

Article 28(1)(c)(i) The proviso to article 28(1)(c)(i) which reads "Provided that where any of the parties to the act is a woman, it shall also be stated whether she is a spinster, a married woman or a widow," is being cancelled in its totality.

Objects and Reasons

The purpose of this Bill is to ensure the removal of discrimination and interference in one's private life as was declared by the Constitutional Court in its judgment of the 26 January 2018 in the names '*Marie Therese Cuschieri v. Avukat Generali*', to ensure that this be the first step towards the taking of all necessary administrative measures for the violation of human rights found by the Constitutional Court to be halted and to ensure that gender based discrimination does not persist.
