## ABBOZZ TA' LIĠI

*ATT biex ikompli jemenda l-Att ta' l-1976 dwar l-Aġenziji ta' l-Ivvjaġġar u Servizzi tal-Lukandi.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, ħareġ b'liġi dan li ġej:—

Titolu fil-qosor.

**1.** Dan l-Att jista' jissejjaħ l-Att ta' l-1982 li jemenda l-Att dwar l-Aġenziji ta' l-Ivvjaġġar u Servizzi tal-Lukandi, u għandu jinqara u jif-tiehem ħaġa waħda ma' l-Att ta' l-1976 dwar l-Aġenziji ta' l-Ivvjaġġar u Servizzi tal-Lukandi, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

Emenda ta' l-artikolu 3 ta' l-Att prinċipali.

**2.** Fis-subartikolu (2) ta' l-artikolu 3 ta' l-Att prinċipali minflok il-kliem "multa ta' mhux iżjed minn £500" għandhom jidhlu l-kliem "multa ta' mhux inqas minn £500 iżda mhux iżjed minn £1000".

Emenda ta' l-artikolu 7 ta' l-Att prinċipali.

**3.** Fis-subartikolu (3) ta' l-artikolu 7 ta' l-Att prinċipali minflok il-kliem "multa ta' mhux iżjed minn £20 u multa ta' £2 għal kull jum" għandhom jidhlu l-kliem "multa ta' mhux inqas minn £100 iżda mhux iżjed minn £500 u multa ta' £10 għal kull jum".

L-Għan ta' dan l-Abbozz huwa li jemenda l-Att ta' l-1976 dwar l-Aġenziji ta' l-Ivvjaġġar u Servizzi tal-Lukandi, sabiex tiżdied il-piena ta' multa f'żewġ każijiet.

## A BILL

### entitled

*AN ACT further to amend the Travel Agencies and Hotel Services Act, 1976.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Travel Agencies and Hotel Services (Amendment) Act, 1982, and shall be read and construed as one with the Travel Agencies and Hotel Services Act, 1976, hereinafter referred to as “the principal Act”. Short title.

2. In subsection (2) of section 3 of the principal Act for the words “to a fine (*multa*) not exceeding £500” there shall be substituted the words “to a fine (*multa*) of not less than £500 but not exceeding £1000”. Amendment of section 3 of the principal Act.

3. In subsection (3) of section 7 of the principal Act for the words “to a fine (*multa*) not exceeding £20 and to a fine (*multa*) of £2 for every day” there shall be substituted the words “to a fine (*multa*) of not less than £100 but not exceeding £500 and to a fine (*multa*) of £10 for every day”. Amendment of section 7 of the principal Act.

## Objects and Reasons

The Object of this Bill is to amend the Travel Agencies and Hotel Services Act, 1976, so as to raise the penalty of a fine in two instances.
