## ABBOZZ TA' LIĠI imsejjah

*ATT biex jemenda l-Att dwar l-Uffiċċju tal-Posta, Kap. 254.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, ħareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1994 li jemenda l-Att dwar l-Uffiċċju tal-Posta, u għandu jinqara u jiftiehem haġa waħda ma' l-Att dwar l-Uffiċċju tal-Posta, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

2. Wara t-tieni proviso għas-subartikolu (1) ta' l-artikolu 27 ta' l-Att prinċipali għandu jiżdied dan il-proviso li ġej:

"Iżda wkoll meta l-*Postmaster-General* ikun sodisfatt li oġġett postali li jkun indirizzat lil persuna li jkollha jedd bil-liġi li tipprovdi servizzi ta' xandir bit-televiżjoni f'Malta ikun jikkonsisti f'materjal awdjoviziv li jkun ġie impustat jew mibghut bil-posta bil-ghan biss li jixxandar fuq it-televiżjoni skond id-dispożizzjonijiet ta' l-Att dwar ix-Xandir u ta' kull regolament magħmul jew liċenza mahruġa taħt dak l-Att, hija għandha, minkejja d-dispożizzjonijiet ta' dan l-artikolu u ta' l-artikolu 26 ta' dan l-Att, tikkonsinna dak l-oġġett postali lil min ikun indirizzat mingħajr ebda eżami jew ċensura oħra."

**A BILL**  
**entitled**

*AN ACT to amend the Post Office Act, Chapter 254.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.  
Cap. 254.

1. This Act may be cited as the Post Office (Amendment) Act 1994, and shall be read and construed as one with the Post Office Act, hereinafter referred to as “the principal Act”.

Amendment of  
section 27  
of the  
principal Act.

2. After the second proviso to subsection (1) of section 27 of the principal Act there shall be added the following proviso:

“Provided further that when the Postmaster General is satisfied that a postal article addressed to a person legally entitled to provide television broadcasting services in Malta consists of audiovisual material which has been posted or sent by post only for the purpose of its being broadcast on television according to the provisions of the Broadcasting Act and of any regulations made or licence issued thereunder, he shall, notwithstanding the provisions of this section and of section 26 of this Act, deliver such postal article to the addressee without further examination or censorship.”.

**Objects and Reasons**

The Object of this Bill is the facilitation of the operation of Maltese television broadcasting stations by ensuring that television programmes shown by them will not be subject to more than one system of classification or censorship.
