## ABBOZZ TA' LIĠI

### msejjah

*ATT dwar il-Bidu fis-Sehh ta' Ċerti Emendi fl-Att dwar is-Sigurtà Soċjali, Kap. 318.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1994 dwar il-Bidu fis-Sehh ta' Ċerti Emendi fl-Att dwar is-Sigurtà Soċjali u għandu jinftihem u jinqara bħala waħda ma' l-Att ta' l-1994 li jemenda l-Att dwar is-Sigurtà Soċjali, (Att Nru. XXV ta' l-1994) hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor  
u bidu fis-sehh.

(2) Dan l-Att għandu jitqies li beda jsehh fil-21 ta' Ottubru, 1994, u d-dispożizzjonijiet tas-subartikolu (2) ta' l-artikolu 1 ta' l-Att prinċipali għandhom jitqiesu li qatt ma dahl fuq fis-sehh qabel l-emenda magħmula bl-artikolu 2 ta' dan l-Att, u l-Att dwar is-Sigurtà Soċjali (Kap. 318) għandu jinqara u jinftihem skond hekk.

2. L-artikolu 1 ta' l-Att prinċipali għandu jiġi emendat kif ġej:—

(a) fit-test Malti tas-subartikolu (1) tiegħu, minflok il-kliem "is-Sigurtà Soċjali, hawnhekk" għandhom jidhlu l-kliem "is-Sigurtà Soċjali, u għandu jinqara u jinftihem haġa waħda ma' l-Att dwar is-Sigurtà Soċjali, hawnhekk"; u

(b) minflok is-subartikolu (2) tiegħu, għandu jidhol dan li ġej:—

"(2) Dan l-Att għandu jitqies li beda jsehh kif ġej:—

(a) l-artikoli 2 u 3, 5 sa 7, il-paragrafi (b) sa (d) ta' l-artikoli 8, l-artikoli 9 sa 24, 26 sa 29, 32 sa 37 u l-artikolu 39 għandhom jitqiesu li bdew isehħu fl-1 ta' Jannar, 1994;

(b) il-paragrafu (a) ta' l-artikolu 8 għandu jitqies li beda jsehh fl-1 ta' Ottubru, 1994;

(c) l-artikolu 25 għandu jitqies li beda jsehh fl-4 ta' Jannar, 1992;

(d) l-artikoli 30 u 31 għandhom jibdew isehhu malli dan l-Att isir liġi; u

(e) l-artikoli 4 u 38 għandhom jitqiesu li bdew isehhu fit-3 ta' Jannar, 1994.”.

### Għanijiet u Raġunijiet

L-Għan ta' dan l-Abbozz huwa sabiex jirratifika d-dispożizzjonijiet li għandhom x'jaqsmu mal-bidu fis-sehh ta' l-Att ta' l-1994 li jemenda l-Att dwar is-Sigurtà Soċjali.

**A BILL**  
**entitled**

*AN ACT concerning the Coming into Force of Certain Amendments to the Social Security Act, Cap. 318.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:—

1. (1) This Act may be cited as the Social Security (Coming into Force of Certain Amendments) Act, 1994 and shall be read and construed as one with the Social Security (Amendment) Act, 1994, (Act No. XXV of 1994) hereinafter referred to as “the principal Act”.

Short title and commencement.

(2) This Act shall be deemed to have come into force on the 21st October, 1994, and the provisions of subsection (2) of section 1 of the principal Act shall be deemed as never having come into force prior to the amendment made by section 2 of this Act, and the Social Security Act (Cap. 318) shall be read and construed accordingly.

2. Section 1 of the principal Act shall be amended as follows:—

Amendment of section 1 of the principal Act.

(a) in the Maltese text of subsection (1) thereof, for the words “is-Sigurtà Soċjali, hawnhekk”, there shall be substituted the words “is-Sigurtà Soċjali, u għandu jinqara u jinftihem haġa wahda ma’ l-Att dwar is-Sigurtà Soċjali, hawnhekk”; and

(b) for subsection (2) thereof, there shall be substituted the following:—

“(2) This Act shall be deemed to have come into force as follows:—

(a) sections 2 and 3, 5 to 7, paragraphs (b) to (d) of section 8, sections 9 to 24, 26 to 29, 32 to 37 and section 39 shall be deemed to have come into force on 1st January, 1994;

(b) paragraph (a) of section 8 shall be deemed to have come into force on 1st October, 1994;

(c) section 25 shall be deemed to have come into force on the 4th January, 1992;

(d) sections 30 and 31 shall come into force on the enactment of this Act; and

(e) sections 4 and 38 shall be deemed to have come into force on 3rd January, 1994.”.

### **Objects and Reasons**

The object of this Bill is to rectify the commencement provisions of the Social Security (Amendment) Act, 1994.
