ABBOZZ TA' LIĠI msejjah

*ATT biex jemenda l-Att dwar il-Promozzjoni ta' Prodotti Lokali,
Kap. 336*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f' dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att li jemenda l-Att dwar il-Promozzjoni ta' Prodotti Lokali, u għandu jinqara u jiftiehem haġa waħda ma' l-Att dwar il-Promozzjoni ta' Prodotti Lokali, hawnhekk aktar 'il quddiem imsejjah "l-Att prinċipali". Kap. 336.

(2) Dan l-Att jibda jsehh fil-25 ta' Lulju, 1995.

2. L-Ewwel Parti tat-Tieni Skeda għandha tiġi emendata kif ġej:—

(a) Minflok il-levy ta' "7c kull kilo" li tidher hdejn l-HS Codes 0202.30.10.00, 0202.30.50.00 u 0202.30.90.00 relattivi għad-deskrizzjoni, din għandha taqra "30c kull kilo".

Biex tinzamm il-protezzjoni għall-industrija tal-laham fis-settur agrikolu.

**A BILL
entitled**

AN ACT to amend the Local Manufactures (Promotion) Act, Cap. 336

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Local Manufactures (Promotion) (Amendment 2) Act, 1995 and shall be read and construed as one with the Local Manufactures (Promotion) Act hereinafter referred to as “the principal Act”.

Cap. 336.

(2) This Act shall come into force on the 25th July, 1995.

2. The First Part of the Second Schedule shall be amended as follows:—

(a) the rate of levy at 7c per kg appearing against H.S. Codes 0202.30.10.00, 0202.30.50.00 and 0202.30.90.00 and the relative description “beef cuts, frozen, boneless” shall be amended to read “30c per kg”.

Object

To maintain protection for the livestock industry in the agricultural sector.
