ACT No. XV of 1992*AN ACT to amend the Import Duties Act, 1989.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Import Duties (Amendment) Act, 1992, and shall be read and construed as one with the Import Duties Act, 1989, hereinafter referred to as “the principal Act”.

Short title and commencement.

Act XXXV of 1989.

(2) This Act shall come into force as follows:

(a) the provisions of paragraphs (e) and (f) of section 3 shall be deemed to have come into force on the 2nd December, 1991;

(b) the provisions of paragraphs (a), (b), (g) and (h) of section 3 and of paragraph (a) of section 4 shall be deemed to have come into force on the 1st January, 1992;

(c) the provisions of section 2, paragraphs (c), (d) and (i) of section 3, and paragraph (b) of section 4 shall be deemed to have come into force on the 24th July, 1992; and

(d) the provisions of paragraphs (j), (k), (l) and (m) of section 3 shall be deemed to come into force on the date of publication of this Act.

2. Section 5 of the principal Act shall be amended as follows:

(a) the present provision shall be renumbered as subsection (1) thereof; and

(b) immediately after subsection (1) thereof as renumbered, there shall be added the following new subsection:

“(2) The Minister may by regulations from time to time prescribe the conditions under which and the extent by which equipment for use in any establishment or trade may be exempted from payment of import duty.”.

Amendment of Second Schedule to the principal Act.

4. The Second Schedule to the principal Act shall be amended as follows:

(a) in item II thereof, for paragraph (q) there shall be substituted the following:

“(q) (i) Passengers’ baggage, including wearing apparel and personal effects, used, which the Comptroller of Customs is satisfied are intended for the passengers’ personal use, but excluding firearms and weapons of all kinds;

(ii) Such tobacco products, wines, spirits, toilet waters and perfumes as may be allowed in accordance with the Convention concerning Customs Facilities for Touring made at New York on the 4th June, 1954;

(iii) Such goods bought for the passenger’s own use or as *bona fide* gifts, other than the goods mentioned in subparagraphs (i) and (ii) hereof up to a value of Lm50, so however that where the total value of such goods exceeds Lm50, this provision shall not apply and the duty chargeable on such goods shall be deducted by Lm13”; and

(b) item III thereof relating to equipment for use in hotels and catering establishments shall be deleted.
