ACT No. XVII of 1992

AN ACT to repeal the Aircraft (Photography) Ordinance, Cap. 51.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Aircraft (Photography) (Repeal) Act, 1992, and shall be read and construed as one with the Aircraft (Photography) Ordinance, hereinafter referred to as “the principal law”.

Repeal of the
principal law.

2. The principal law is hereby repealed.
