2. Minnufih wara s-subartikolu (2) tal-artikolu 14 tal-Att prinċipali, għandu jiżdied is-subartikolu ġdid li ġej:

Emenda tal-artikolu 14 tal-Att prinċipali.

"(2A)Minkejja d-dispożizzjonijiet tas-subartikolu (2), meta jkun ingħata jew ġie mwaħħal xi avviż kif provdut fis-subartikolu (2) u l-ewwel proviso tiegħu, tali avviż jista', minflok l-informazzjoni msemmija taht is-subartikolu (2), ikun fih informazzjoni dwar kif wiehed jista' jaċċessa u jara dik l-informazzjoni permezz ta' mezzi elettronici u l-perjodu li fih wiehed jista' hekk jaċċessa u jara tali informazzjoni:

**A BILL
entitled**

AN ACT to amend the Commissioners for Justice Act. Cap 291.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Commissioners for Justice (Amendment) Act, 2020 and this Act shall be read and construed as one with the Commissioners for Justice Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 291

2. Immediately after sub-article (2) of article 14 of the principal Act, there shall be added the following sub-article:

Amendment to article 14 of the principal Act.

"(2A)Notwithstanding the provisions of sub-article (2), where any notice is handed over or is affixed as is provided in sub-article (2) and the first proviso thereto, such notice may, instead of the information mentioned under sub-article (2), contain information as to how that information may be accessed and viewed through electronic means and the period within which such information may be so accessed and viewed:

Provided that where the information is not accessed and viewed within the period indicated in such notice, a notice containing the information mentioned under sub-article (2) shall be sent by mail or by any other means as provided by law."

Objects and Reasons

The objects and reasons of this Bill are to provide for the possibility of informing a person who has committed a scheduled offence that an offence has been committed by a notice leading the offender to view and access the details of the offence through electronic means.
