AN ACT to amend the Education Act, Cap. 327.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.
Cap. 327

1. This Act may be cited as the Education (Amendment) Act, 1993, and shall be read and construed as one with the Education Act, hereinafter referred to as “the principal Act”.

Amendment of
section 32

2. In paragraph (g) in section 32 of the principal Act, immediately after the words “appointed by the Minister” there shall be added the words “and a member appointed by the Foundation for Theological Studies”.

Amendment of
section 36
of the
principal Act.

3. In paragraph (f) in section 36 of the principal Act, immediately after the words “administration of the Faculty” there shall be added the words “provided that the two members representing the interests outside the Faculty of Theology shall be appointed by the Minister in conformity with the indications given by the Foundation for Theological Studies”.

Objects and Reasons

The Object of this Bill is to amend the Education Act regarding the Composition of the Council of the University and the Composition of the Faculty Boards.
