ACT No. LV of 2020

AN ACT to further amend the Constitution relative to the age of retirement of judges and magistrates.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Constitution of Malta (Amendment No. 3) Act, 2020 and this Act shall be read and construed as one with the Constitution of Malta, hereinafter referred to as "the Constitution".

Short title.

2. Sub-article (1) of article 97 of the Constitution shall be substituted by the following new sub-article:

Amendment of article 97 of the Constitution.

"(1) Without prejudice to the provisions of this article, a judge of the Superior Courts shall vacate his office upon reaching the age of sixty-five (65) years:

Provided that a judge of the Superior Courts shall inform the Chief Justice and the President of Malta of this decision before he reaches the age of sixty-five (65) years once he chooses to remain in office until he reaches the age of sixty-eight (68) years."

3. Sub-article (3) of article 100 of the Constitution shall be substituted by the following new sub-article:

"(3) Without prejudice to sub-article (4), a magistrate of the inferior courts shall vacate his office upon reaching the age of sixty-five (65) years:

Provided that a magistrate of the inferior courts shall inform the Chief Justice and the President of Malta of this decision before he reaches the age of sixty-five (65) years once he chooses to remain in office until he reaches the age of sixty-eight (68) years."
