ACT No. VIII of 1994

AN ACT further to amend the Import Duties Act, Cap. 337.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.
Cap. 337.

1. (1) This Act may be cited as the Import Duties (Amendment) Act, 1994, and shall be read and construed as one with the Import Duties Act, hereinafter referred to as "the principal Act".

(2) The following provisions of this Act shall come into force as follows:

(a) the provisions of paragraphs (a), (b), (c), (d), (e) and (f) of section 2 shall be deemed to have come into force on the 24th November, 1993;

(b) the provisions of paragraphs (g), (h), (i), (j), (k), (l), (m), (n), (o), (p), and (q) of section 2 shall come into force on the 1st January, 1994, and

(c) the provisions of paragraphs (a) and (b) of section 3 shall come into force on the 1st July, 1994.

Amendment of First Schedule to the principal Act.

2. The First Schedule to the principal Act shall be amended as follows:

(a) for the National Note to Chapter 1 there shall be substituted the following new National Note:

“NATIONAL NOTE

For duty purposes:

Animals for breeding purposes, classified under headings Nos. 01.01, 01.02, 01.03, 01.04 and 01.06 when imported accompanied by pedigree certificates to the satisfaction of the Director of Agriculture shall be allowed free of import duty;

Poultry, classified under heading No. 01.05, of improved strain, and so certified by the Director of Agriculture, shall be allowed free of import duty; and

Live insects, classified under heading No. 01.06, imported for the biological control of pests, and so certified by the Director of Agriculture, shall be allowed free of import duty.”;

Amendment of Second Schedule to the principal Act.

3. Item II of the Second Schedule to the principal Act shall be amended as follows:

(a) for paragraph (o), including the proviso, there shall be substituted the following:

“(o) One private motor-vehicle imported by a person (husband and wife counting as one person for the purposes hereof) who transfers his residence to Malta subject to such person satisfying the Comptroller of Customs that:

(i) he is in possession of a permit of residence issued to him by the Government in terms of subsection (1) of section 7 of the Immigration Act (Cap. 217); and

(ii) the motor-vehicle has been in his ownership for a continuous period of at least six months immediately before the issue of the said permit, provided that customs charges and/or fiscal charges to which such vehicle is normally liable have been paid either in the country of origin or in the country of departure and subject to the motor-vehicle being imported within six months of the date of the said permit or of such person's arrival in Malta to take up residence, whichever date is the later:

Provided that, where any motor-vehicle imported as aforesaid free of duty is sold or disposed of by such person for use in Malta, such motor-vehicle shall be deemed to be taken out of bond at the time of such sale or disposal and duty shall be payable thereon by the person who becomes the owner thereof in accordance with the provisions of section 4 of this Act”;

(b) for paragraph (p), including the proviso, there shall be substituted the following:

“(p) One private motor-vehicle imported by a Maltese migrant (husband and wife counting as one person for the purposes hereof) who returns to reside in Malta, subject to such migrant satisfying the Comptroller of Customs that:

(i) he has been residing outside Malta for an aggregate of ten years during the period of fifteen years immediately preceding his arrival in Malta to take up residence; and

(ii) the motor-vehicle has been in his ownership for a continuous period of at least six months immediately before his arrival in Malta to take up residence, provided that customs charges and/or fiscal charges to which such vehicle is normally liable have been paid either in the country of origin or in the country of departure and subject to the motor-vehicle being imported within six months of such migrant's arrival in Malta to take up residence:

Provided that, where any motor-vehicle imported as aforesaid free of duty is sold or disposed of by such person for use in Malta, such motor-vehicle shall be deemed to be taken out of bond at the time of such sale or disposal and duty shall be payable thereon by the person who becomes the owner thereof in accordance with the provisions of section 4 of this Act”.

4. Pursuant to section 12A of the principal Act, the new duty or increased rate of duty leviable in accordance with this Act, shall be leviable on any goods in relation to which a perfect bill of entry has been made but have not been released up to the time of the issue by the President of the relative Proclamation under the Revenue Safeguard Act, relative to this Act.
