entitled**

AN ACT to amend the National Holidays and Other Public Holidays Act, Cap. 252.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the National Holidays and Other Public Holidays (Amendment) Act 2021, and this Act shall be read and construed as one with the National Holidays and Other Public Holidays Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 252.

2. Immediately after paragraph (b) of article 6 of the principal Act there shall be added the following new paragraph:

Amendment of article 6 of the principal Act.

"(c) with effect from 1st January 2021, when a national holiday or a public holiday listed in the Schedule falls on a Saturday or on a Sunday, it shall be deemed to be a public holiday for the purposes of entitling any person to a day of vacation leave in addition to the leave entitlement for that particular year as calculated on the basic entitlement provided in regulation 8 of the Organisation of Working Time Regulations."

Objects and Reasons

The objects and reasons of this Bill are to establish that when a national holiday or a public holiday falls on a Saturday or on a Sunday, it shall be deemed to be a public holiday for the purposes of entitling any person to a day of vacation leave in addition to the leave entitlement for that particular year.
