2. Fis-subartikolu (1) tal-artikolu 4 tal-Att prinċipali, il-kliem "biljun u mitt miljun euro (€1,100,000,000) għandhom jiġu sostitwiti bil-kliem "żewġ biljuni u mitt miljun euro (€2,100,000,000)".
Emenda tal-artikolu 4 tal-Att prinċipali.

Għanijiet u Raġunijiet

L-għanijiet u r-raġunijiet ta' dan l-Abbozz ta' Liġi huma maħsuba sabiex jiġu pprovduti aktar fondi sabiex ikunu jistgħu jiġu ffinanzjati l-miżuri tal-Budget 2021 u jagħmel tajjeb għal aktar nuqqas ta' dħul fil-finanzi tal-gvern relatati magħhom. Il-biċċa l-kbira tal-bżonn sabiex jiġu pprovduti aktar fondi hija minħabba li se jinżammu fis-seħħ għall-perijodu ta' żmien aktar milli kien maħsub oriġinarjament fil-Budget tal-2021, numru ta' miżuri fiskali ta' sapport bla preċedent li ġew introdotti fl-2020 sabiex jitnaqqas l-impatt negattiv tal-pandemija tal-COVID-19 fuq l-ekonomija.

*AN ACT to amend the Budget Measures Implementation Act, 2021
ACT No. XVIII of 2021*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.

1. The short title of this Act is the Budget Measures Implementation Act, 2021 (Amendment) Act, 2021 and this Act shall be read and construed as one with the Budget Measures Implementation Act, 2021, hereinafter referred to as "the principal Act".

Amendment of

2. In sub-article (1) of article 4 of the principal Act, the words "one billion and one hundred million euro (€1,100,000,000)" shall be substituted by the words "two billion and one hundred million euro (€2,100,000,000)".

Objects and Reasons

The objects and reasons of this Bill are to provide for additional funds to finance the Budget 2021 measures and to make good for further corresponding government revenue shortfalls arising. The need to provide additional funds is largely a result of keeping in place beyond the period originally contemplated in the 2021 Budget, several unprecedented fiscal policy support measures which had been introduced in 2020 to mitigate the negative impact of COVID-19 pandemic on the economy.
