ACT No. XXXIX of 2021

AN ACT to amend the Animal Welfare Act, Cap. 439.

BE IT ENACTED by the President, by and with the advice and consent to the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Animal Welfare (Amendment) Act, 2021 and this Act shall be read and construed as one with the Animal Welfare Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 439.

2. In paragraph (b) of sub-article (1) of article 45 of the principal Act, the words "to both such fine and imprisonment." shall be substituted by the words "to both such fine and imprisonment:" and immediately thereafter there shall be added the following proviso:

Amendment of article 45 of the principal Act.

"Provided that when a person is found guilty of a breach of the provisions of this Act consisting of ill-treatment of animals, the court may when it deems it to be appropriate, in addition to the punishment, prohibit the person found guilty from keeping animals or from residing in a place where animals are kept for such period as the court may determine."
