ACT No. VII of 2000

AN ACT to amend the Excise Duty Act, 1995.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Excise Duty (Amendment) Act, 2000, and shall be read and construed as one with the Excise Duty Act, 1995, hereinafter referred to as “the principal Act”.

Short title and commencement.

Act XVI of 1995.

(2) This Act shall be deemed to have come into force on the 22nd November, 1999.

2. The Third Schedule to the principal Act shall be amended as follows:

Amendment of Third Schedule to the principal Act.

(a) for the item “Cigarettes classified in Customs Tariff heading No. 24.02:” and the words in the first and second columns relative thereto, there shall be substituted the following:

(b) for the item “– Other smoking tobacco, whether or not containing tobacco substitutes in any proportion” in the first column and the words relative thereto in the second column, there shall be substituted the following:

<p>“ – Other smoking tobacco, whether or not containing tobacco substitutes in any proportion</p>	<p>Lm11.81,0 kull kg. ”.</p>
