ATT sabiex jemenda l-Att dwar id-Dħul ta' Malta bhala Membru tal-Fond Monetarju Internazzjonali, Kap. 209.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament u bl-awtorità tal-istess, hareġ b'liġi dan li ġej:

1. (1) It-titolu fil-qosor ta' dan l-Att huwa l-Att tal-2021 li jemenda l-Att dwar id-Dħul ta' Malta bhala Membru tal-Fond Monetarju Internazzjonali u għandu jinqara u jinftiehem haġa waħda mal-Att dwar id-Dħul ta' Malta bhala Membru tal-Fond Monetarju Internazzjonali iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor u bidu fis-seħh.

(2) Dan l-Att għandu jidhol fis-seħh f'dik id-data li l-Ministru responsabbli għall-finanzi u s-servizzi finanzjarji jista' jistabbilixxi permezz ta' avviż fil-Gazzetta, u jistgħu jiġu hekk stabbiliti dati differenti għal dispożizzjonijiet u għanijiet differenti ta' dan l-Att.

2. Fis-subartikolu 2 tal-artikolu 6 tal-Att prinċipali l-kliem "Sezzjoni 5 tal-Artikolu III tal-Ftehim tal-Fond", għandhom jiġu sostitwiti bil-kliem "Sezzjoni 4 tal-Artikolu III tal-Ftehim tal-Fond".

Emenda tal-artikolu 6 tal-Att prinċipali.

3. L-artikolu 8 tal-Att prinċipali għandu jiġi sostitwit bl-artikolu ġdid li ġej:

Sostituzzjoni tal-artikolu 8 tal-Att prinċipali.

"Setgħat tal-Ministru.

8. (1) Il-Ministru jista' b'ordni jagħmel dawk id-dispożizzjonijiet li jkunu meħtieġa biex jagħti effett lil kull waħda mid-dispożizzjonijiet tal-Ftehim tal-Fond.

(2) Il-Ministru jista', minn żmien għal żmien, permezz ta' ordni jemenda, iħassar jew jissostitwixxi l-Iskedi ta' dan l-Att.

L-għanijiet u r-raġunijiet ta' dan l-Abbozz ta' Liġi huma sabiex tiġi emendata l-Iskeda annessa mal-Att dwar id-Dħul ta' Malta bħala Membru tal-Fond Monetarju Internazzjonali, Kap. 209.

**A BILL
entitled**

An ACT to amend the Malta Membership of the International Monetary Fund Act, Cap 209.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows:-

1. (1) The short title of this Act is the Malta Membership of the International Monetary Fund (Amendment) Act, 2021, and this Act shall be read and construed as one with the Malta Membership of the International Monetary Fund Act, hereinafter referred to as "the principal Act".

Short title and commencement.

(2) This Act shall come into force on such date as the Minister responsible for finance and financial services may, by notice in the Gazette establish, and different dates may be so established for different provisions and purposes of this Act.

2. In sub-article 2 of article 6 of the principal Act, the words "Section 5 of Article III of the Fund Agreement", shall be substituted by the words "Section 4 of Article III of the Fund Agreement".

Amendment of article 6 of the principal Act.

3. Article 8 of the principal Act shall be substituted by the following new article:

Substitution of article 8 of the principal Act.

"Powers of the Minister.

8. (1) The Minister may by order make such provisions as are necessary for carrying into effect any of the provisions of the Fund Agreement.

(2) The Minister may, from time to time by order, amend, repeal or substitute the Schedules made under this Act.

(3) Any Schedules made under this Act and any amendment or revocation of the said Schedules may be made in the English language only."
