**2.** Il-paragrafu (b) tal-artikolu 912 tal-Kodiċi għandu jiġi emendat kif ġej:

Emenda tal-artikolu 912 tal-Kodiċi.

(a) il-kliem "li l-valur nett tagħhom jammonta għal, jew ikun aktar minn, sitt elef disa' mija u tmienja u tmenin euro u tnax-il ċenteżmu (6,988.12)," għandhom jiġu sostitwiti bil-kliem "li l-valur nett tagħhom jammonta għal, jew ikun aktar minn, tlettax-il elf euro (€13,000),"; u

(b) minnufih wara l-ewwel proviso tiegħu għandu jizjed il-proviso ġdid li ġej:

"Izda wkoll fil-kalkolu tal-valur nett imsemmi, għandu jittiehed kont tal-kera mħallsa għall-proprjetà użata bhala r-residenza prinċipali, mal-preżentazzjoni ta' kuntratt reġistrat skont il-liġi u rċevuti ta' ħlas rilevanti; u għandu jittiehed kont tal-manteniment li għandu jithallas

entitled**

*AN ACT to amend the Code of Organization and Civil Procedure,  
Cap. 12.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Code of Organization and Civil Procedure (Amendment No. 5) Act, 2022 and this Act shall be read and construed as one with the Code of Organization and Civil Procedure, hereinafter referred to as "the Code".

Short title.

Cap. 12.

2. Paragraph (b) of article 912 of the Code shall be amended as follows:

Amendment of article 912 of the Code.

(a) the words "the net value whereof amounts to, or exceeds, six thousand and nine hundred and eighty-eight euro and twelve cents (6,988.12)," shall be substituted by the words "the net value whereof amounts to, or exceeds, thirteen thousand euro (€13,000),"; and

(b) immediately after the first proviso thereof there shall be added the following new proviso:

"Provided further that in calculating the said net asset value, account shall be taken of the rent paid for the property used as the main residence, upon presentation of a registered contract according to law and relevant payment receipts; and account shall be taken of the maintenance payable to the other spouse and children,

issued by a Court order, upon presentation of relevant evidence of payment:".

### **Objects and Reasons**

The objects and reasons of this Bill are to update the current existing law in order to enable indigent people a more fair, reasonable means testing law which would reflect the current cost of living of poorer people in society.
