I am delighted to invite you to the CAPAC Conference which will be hosted in the **People's Majils (parliament) of the Maldives on Tuesday 30 and Wednesday 31 August**. Many thanks to Hon. Nashiz and the People's Majils for kindly offering to host the CAPAC Conference.

The conference will take place over 2 days (30 - 31 August) and will include a half day general meeting and one day of substantive sessions. The general meeting will include elections for a new Chair, as Dame Meg Hillier MP has come to the end of her term as Chair and is therefore stepping down, and for new members of ExCo. The substantive sessions will be a great opportunity to share learning with peers on the work of PACs during COVID-19 and the most effective ways of utilising PAC networks.

We would encourage 2 representatives to attend from each legislature - the CAPAC contact and CAPAC representative (usually the PAC Clerk and Chair). If you are unable to travel to the Maldives, we hope to make provisions for virtual participation.

CAPAC Members are required to pay for their own travel, accommodation and expenses. We will be in touch with options for accommodation.
