AN ACT to further amend the Criminal Code, Cap. 9.

BE IT ENACTED by the President, by and with the advice and consent to the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

- Short title. **1.** The short title of this Act is the Criminal Code (Amendment No. 3) Act, 2023 and this Act shall be read and construed as one with
- Cap. 9. the Criminal Code, hereinafter referred to as "the Code".
- Amendment of **2.** In article 251H of the Code, the words "in each of the following cases:" shall be substituted by the words "in case of one or more of the following circumstances arising:".
- article 251H of
the Code.
- Amendment of **3.** In article 251HA of the Code, the words "in each of the cases referred to in article 202," shall be substituted by the words "in case of one or more of the circumstances referred to in article 202,".
- article 251HA
of the Code.

Objects and Reasons

The objects and reasons of this Bill are to clarify the way the punishment is calculated in case of aggravating circumstances.
