ACT No. XIII of 2023

AN ACT to amend the Affirmation of Sexual Orientation, Gender Identity and Gender Expression Act, Cap. 567.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the Affirmation of Sexual Orientation, Gender Identity and Gender Expression (Amendment) Act, 2023 and this Act shall be read and construed as one with the Affirmation of Sexual Orientation, Gender Identity and Gender Expression Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 567.

2. In article 2 of the principal Act, immediately before the definition "conversion practices" thereof there shall be added the following new definition:

Amendment of article 2 of the principal Act.

" "advertise" means the publication, display, sharing, promotion, referral, circulation of, or authorisation to publish, display, share, promote, refer or circulate any material made by any means which indicates, or could reasonably be understood as indicating, that the person so advertising or authorising the advertising has engaged in conversion practices, or is favourably describing, endorsing or promoting conversion practices;"
