AN ACT further to amend the Import Duties Act, 1976.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Import Duties (Amendment) (No. 3) Act, 1985, and shall be read and construed as one with the Import Duties Act, 1976, hereinafter referred to as "the principal Act".

Short title and commencement.
Act No. XXV of 1976

(2) The provisions of paragraph (a) of section 2 of this Act shall be deemed to have come into force on the 2nd day of December, 1985.

2. The First Schedule to the principal Act shall be amended as follows:

Amendment of the First Schedule to the principal Act.

(a) for sub-heading (A) of heading 85.15 and for the figures in respect thereof in the Second and Third Columns there shall be substituted respectively the sub-heading shown in the First Column and the relative figures shown in the Second and Third Columns hereunder:

“(A) Transmission, reception apparatus, and television cameras used in radio, telegraph and telephone stations:		
(1) Cordless telephones	72	67
(2) Other	0	0 ³ ; and

(b) for the heading 92.11 and for the figures in respect thereof in the Second and Third Columns there shall be substituted respectively the heading shown in the First Column and the relative figures shown in the Second and Third Columns hereunder:

First Column	Second Column	Third Column
"92.11 Gramophones, dictating machines and other sound recorders and reproducers, including record-players and tape decks with or without sound-heads; television image and sound recorders and reproducers, magnetic.	90	85".

Objects and Reasons

The Object of this Bill is to impose duty on cordless telephones and to reduce the rate of import duty on magnetic television image and sound recorders and reproducers.
