*ATT biex ikompli jemenda l-Ordinanza dwar id-Drittijiet, Kap. 58.*

IL-PRESIDENT, bir-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1986 li jemenda l-Ordinanza dwar id-Drittijiet, u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar id-Drittijiet, hawnhekk iżjed 'il quddiem imsejha "il-liġi prinċipali".

Titolu fil-qosor.

2. Fl-artikolu 5 tal-liġi prinċipali minflok il-kliem "b'ordni" għandhom jidhlu l-kliem "b'regolamenti", u minflok il-kliem "ta' bolli mill-uffiċjal li jirċievi dak il-ħlas, skond il-liġijiet li jkunu jsehhu għall-ġbir ta' drittijiet ta' bolli" għandhom jidhlu l-kliem "bolli tal-pustaġġ b'dak il-mod li jista' jkun provdut f'dawk ir-regolamenti".

## A BILL

### entitled

*AN ACT further to amend the Fees Ordinance, Cap. 58.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Fees (Amendment) Act, 1986, and shall be read and construed as one with the Fees Ordinance, hereinafter referred to as "the principal law".

Amendment of section 5 of the principal law.

2. In section 5 of the principal law for the words "by order" there shall be substituted the words "by regulations", and for the words "stamps by the officer receiving such payment, in accordance with the laws in force for the collection of stamp duty" there shall be substituted the words "postage stamps in such manner as may be provided in such regulations".

### Objects and Reasons

The Object of the bill is to provide for the payment of fees by the affixing of postage stamps.
