*ATT* biex ikompli jemenda l-Ordinanza dwar l-Organizzazzjoni tad-Dipartiment tas-Saħħa, Kap. 148.

**IL-PRESIDENT**, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

## A BILL

### entitled

*AN ACT further to amend the Department of Health (Constitution) Ordinance, Cap. 148.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Department of Health (Constitution) (Amendment) Act, 1986, and shall be read and construed as one with the Department of Health (Constitution) Ordinance, hereinafter referred to as "the principal law".

Amendment of section 39 of the principal law.

2. In subsection (4) of section 39 of the principal law, for the words "before the lapse of one year." there shall be substituted the words "before the lapse of four years.".

### Objects and Reasons

The Object of this Bill is to increase from one year to four years the period during which the members who absent themselves without just cause from meetings of a statutory body constituted under the Ordinance, will be ineligible for re-election to that body.
