**entitled**

*AN ACT to amend the Government Lotteries Act, 1981.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act XXIV of  
1981

1. This Act may be cited as the Government Lotteries (Amendment) Act, 1986, and shall be read and construed as one with the Government Lotteries Act, 1981, hereinafter referred to as “the principal Act”.

Amendment of  
section 4 of the  
principal Act.

2. Paragraph (h) of section 4 of the principal Act shall be substituted by the following:

“(h) the manner in which and conditions under which unclaimed prizes may be disposed of;”.

**Objects and Reasons**

The Object of the Bill is to make provision for the making of regulations for the disposal by the Minister of Finance of unclaimed prizes in the Weekly and Grand Lotteries.
