Artiklu 1

Id-delimitazzjoni tal-Blata Kontinentali appartenenti lill-Kbira Ġemahirija Għarbija Libjana Popolari u Soċjalista u lir-Repubblika ta' Malta rispettivament ġewwa l-meridġani 13° 50' l'vant u 15° 10' l'vant għandhom ikunu arki ta' ċrieki kbar bejn il-ponti li ġejjin fis-sekwenza mogħtija hawn taħt:-

Artiklu 2

Għall-finijiet illustrativi biss il-linja ta' konfini definita bil-ponti kardinali indikati fl-Artiklu 1 hija murija fl-*Admiralty Chart* Numru 176 Skala 1: 1,100,000 f'latitudni 39° 00' ippublikata minn Taunton, 31 ta' Ottubru, 1969, li hija annessa mal-Ftehim u tiffirma parti integrali miegħu.

Artiklu 3

Jekk jiġi stabbilit li r-riżorsi naturali f'qiegħ il-baħar jew taħt l-art tiegħu jostendu fuq iż-żewġ naħat tal-konfini tal-Blata Kontinentali, kif definita fil-Ftehim, b'mod li r-riżorsi li jinsabu fl-area tal-Blata Kontinentali ta' waħda mill-Partijiet jistgħu jiġu sfruttati, kollha jew in parti, mill-area tal-Blata Kontinentali tal-Parti l-oħra, l-awtoritajiet kompetenti taż-żewġ pajjiżi għandhom jiehdu hsieb li jikkonsultaw lil xulxin bil-ghan li jiddeterminaw il-mod kif dawn ir-riżorsi għandhom jiġu sfruttati.

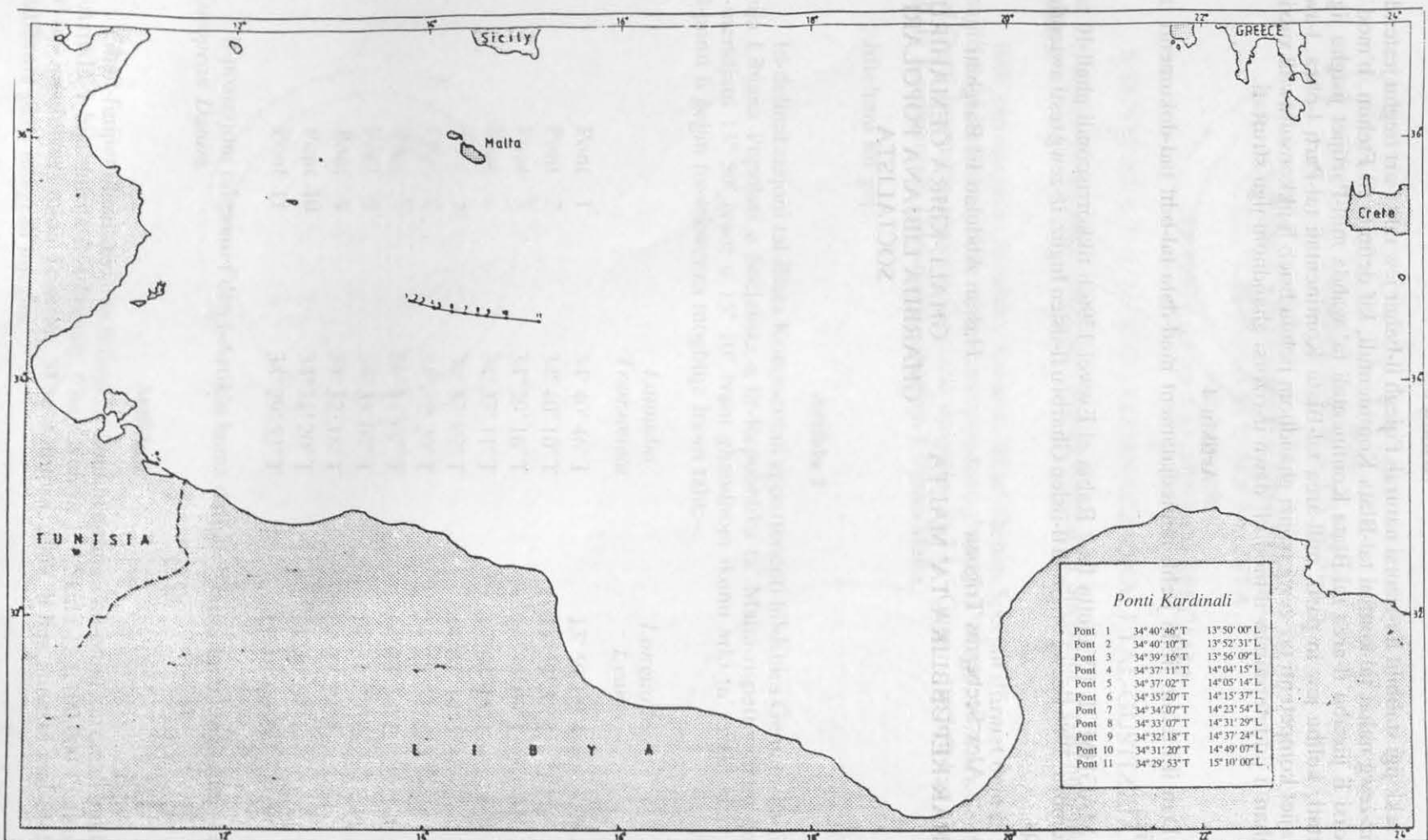
Artiklu 4

**A BILL
entitled**

AN ACT to ratify an Agreement delimiting an area of the Continental shelf between the Republic of Malta and the Great Socialist People's Libyan Arab Jamahiriya.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Malta-Libya Continental Shelf Delimitation (Ratification) Act, 1986.

Ratification
of Agreement

2. The Agreement between the Republic of Malta and the Great Socialist People's Libyan Arab Jamahiriya implementing Article III of the Special Agreement and the Judgement of the International Court of Justice, signed on 10th November, 1986 and a copy of which is contained in the Schedule to this Act, is hereby ratified and authority is hereby given for the exchange of the instruments of ratification relative to the said Agreement for the purposes of Article 4 thereof.

THE JUDGEMENT OF THE INTERNATIONAL COURT OF JUSTICE

The Great Socialist People's Libyan Arab Jamahariya and the Republic of Malta.

Desiring to implement Article III of the Special Agreement signed between the two countries on 24 Jumada Al-Ula, 1396, corresponding to 23rd May, 1976, and the judgement of the International Court of Justice rendered on 3rd June, 1985, in the case concerning the Continental Shelf, Libyan Arab Jamahariya/Malta.

Have agreed as follows:

Article 1

The delimitation of the area of continental shelf appertaining to the Great Socialist People's Libyan Arab Jamahariya and to the Republic of Malta respectively within the meridians 13° 50' east and 15° 10' east shall be arcs of great circles between the following points in the sequence given below:-

The position of the points in this Article are defined by latitude and longitude on European Datum.

Article 2

For illustrative purposes only the boundary line defined by the coordinates indicated in Article 1 above is depicted on the Admiralty Chart No. 176 Scale 1: 1,100,000 at latitude 39° 00' published by Taunton, 31st October 1969, which is annexed to and forms an integral part of this agreement.

Article 3

If it is established that natural resources on the seabed or in its subsoil extend on both sides of the continental shelf boundary, as defined in this Agreement, in such a way that resources situated in the area of continental shelf of one Party are exploitable, wholly or in part, from the area of continental shelf of the other Party, the competent authorities of the two countries shall undertake to consult with each other with a view to determining the manner in which these resources are to be exploited.

Article 4

This Agreement shall enter into force on the date of the exchange of instruments of ratification.

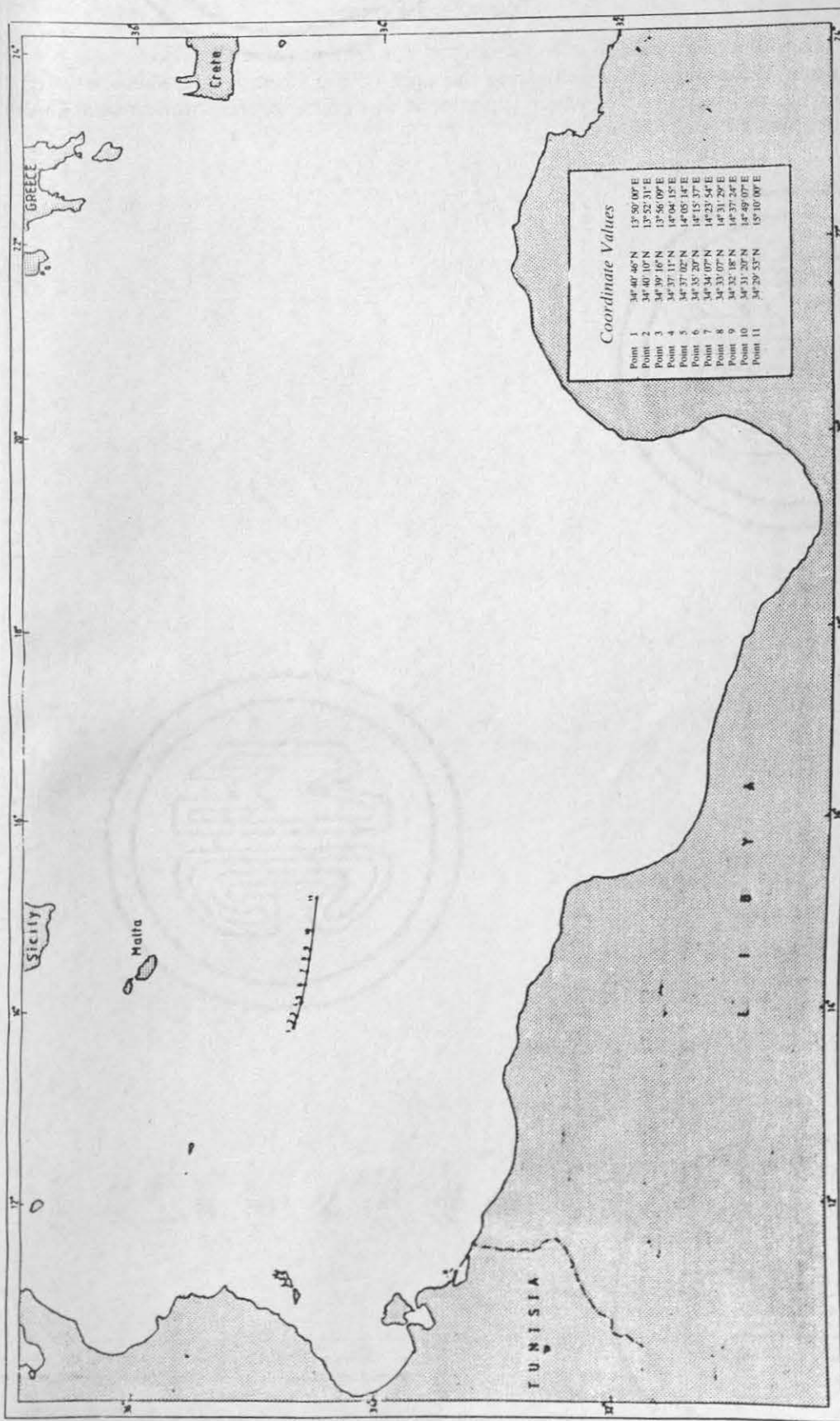

Objects and Reasons

The Object of the Bill is to present to Parliament for ratification the agreement between Malta and Libya delimiting the area of the Continental Shelf between the two countries in respect of which judgement was given by the International Court of Justice on 3rd June 1985.
