IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1984 li jemenda l-Organizzazzjoni tad-Dipartiment tas-Saħħa, u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar l-Organizzazzjoni tad-Dipartiment tas-Saħħa, hawnhekk iżjed 'il quddiem imsejja "il-liġi prinċipali".

Emenda ta' l-artikolu 39 tal-liġi prinċipali.

2. Minnufih wara s-subartikolu (3) ta' l-artikolu 39 tal-liġi prinċipali għandu jidhol is-subartikolu ġdid li ġej:

"(4) Kull membru ta' korp li jassenti ruhu minn tliet laqgħat konsekuttivi ta' dak il-korp mingħajr raġuni ġusta u mingħajr ma jagħti avviż tagħha lill-President jew liċ-*Chairman*, skond il-każ, qabel jew minnufih wara laqgħa ta' dak il-korp, għandu jitqies li jkun irriżenja mill-kariga tiegħu u ma jkun jista' jiġi elett darb'oħra qabel ma tgħaddi sena."

Għanijiet u Raġunijiet

L-Abbozz għandu l-għan li jiżgura attendenza regolari f'laqgħat tal-Kunsill u ta' Bordijiet.

A BILL
entitled

AN ACT further to amend the Department of Health (Constitution) Ordinance, Cap. 148.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Department of Health (Constitution) (Amendment) Act, 1984, and shall be read and construed as one with the Department of Health (Constitution) Ordinance, hereinafter referred to as “the principal law”. Short title.

2. Immediately after subsection (3) of section 39 of the principal law there shall be inserted the following new subsection: Amendment of section 39 of the principal law.

“(4) A member of a body who absents himself from three consecutive meetings of that body without a just cause and without giving notice thereof to the President or Chairman, as the case may be, before or immediately after a meeting of that body, shall be considered to have resigned his office and shall not be eligible for re-election before the lapse of one year.”.

Objects and Reasons

The Bill aims at ensuring the regular attendance at meetings of the Council and the Boards.
