ATT biex ikompli jemenda l-Att ta' l-1965 dwar is-Servizz ta' Gwidi tat-Turisti.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1984 li jemenda l-Att dwar is-Servizz ta' Gwidi tat-Turisti u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1965 dwar is-Servizz ta' Gwidi tat-Turisti, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

Emenda ta' l-artikolu 5 ta' l-Att prinċipali.

2. Minnufih wara s-subartikolu (2) ta' l-artikolu 5 ta' l-Att prinċipali għandu jidhol is-subartikolu ġdid li ġej:

"(3) Kull gwida tat-turisti jista', minn żmien kif jiġi stabbilit mill-Ministru, jkun meħtieġ li joqgħod għal eżami u jikkwalifika fih bħala kondizzjoni għat-tiġdid tal-liċenza tiegħu."

Għanijiet u Ragunijiet

L-Għan ta' dan l-Abbozz huwa li jiżgura li l-hila ta' gwidi tat-turisti liċenzjati tkun kontinwa.

A BILL
entitled

AN ACT further to amend the Tourist Guide Service Act, 1965.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited at the Tourist Guide Service (Amendment) Act, 1984, and shall be read and construed as one with the Tourist Guide Service Act, 1965, hereinafter referred to as "the principal Act". Short title.
2. Immediately after subsection (2) of section 5 of the principal Act there shall be inserted the following new subsection: Amendment of section 5 of the principal Act.
 - "(3) Every tourist guide may from time to time as the Minister may determine be required to sit for and qualify in an examination as a condition for the renewal of his licence."

Objects and Reasons

The Object of this Bill is to ensure the continued proficiency of licensed tourist guides.
