ATT biex ikompli jemenda l-Att ta' l-1975 dwar l-Uffiċċju tal-Posta.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1988 li jemenda l-Att dwar l-Uffiċċju tal-Posta, u għandu jinqara u jftiehem haġa waħda ma' l-Att ta' l-1975 dwar l-Uffiċċju tal-Post, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor u bidu fis-sehħ Att XXXV ta' l-1975.

(2) Dan l-Att għandu jibda jsehħ f'dik id-data li l-Ministru għall-Iżvilupp ta' l-Infrastruttura jista' jistabbilixxi b'avviż fil-Gazzetta.

2. L-artikolu 19 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

Emenda ta' l-artikolu 19 ta' l-Att prinċipali.

(a) is-subartikoli (5), (6), (7) u (8) tiegħu għandhom jiġu enumerati mill-ġdid bħala s-subartikoli (6), (7), (8) u (9) rispettivamente;

(b) minnufih wara s-subartikolu (4) tiegħu għandu jiżdied dan is-subartikolu li ġej:

“(5) Il-postijiet l-oħrajn kollha għandhom ikunu mghammra bi slot għall-ittri li tintlahaq mill-ewwel mit-triq.”;

(c) minflok in-nota marginali għal dan l-artikolu għandu jidhol dan li ġej:

“Postijiet ikunu mghammra b’kaxxi ta’ l-ittri, eċċ.”; u

(d) minnufih f’tarf is-subartikolu (8) kif enumerat mill-ġdid għandu jidhol il-proviso li ġej:

“Izda l-*Postmaster-General* jista’ f’ċirkostanzi speċjali bil-miktub jeżenta persuni milli jikkonformaw mad-dispożizzjonijiet ta’ dan l-artikolu.”.

ACT No. XXXVIII of 1988*AN ACT further to amend the Post Office Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Post Office (Amendment) Act, 1988 and shall be read and construed as one with the Post Office Act, 1975, hereinafter referred to as the “principal Act”. Short title.

(2) This Act shall come into force on such date as the Minister for Development of Infrastructure may appoint by notice in the Gazette.

2. Section 19 of the principal Act shall be amended as follows: Amendment of
section 19 of
the principal Act.

(a) subsections (5), (6), (7) and (8) thereof shall be renumbered as subsections (6), (7), (8) and (9) thereof respectively;

(b) immediately after subsection (4) thereof there shall be added the following subsection:

“(5) All other premises shall be provided with a posting-slot immediately accessible from the street.”;

(c) for the marginal note thereto there shall be substituted the following:

“premises to be provided with letter boxes etc.”; and

(d) immediately at the end of subsection (8) as renumbered there shall be added the following proviso:

“Provided that the Postmaster-General in special circumstances may in writing exempt persons from complying with the provisions of this section.”.
