**ACT No. XX of 1989***AN ACT to amend the Civil Aviation Act, 1972.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Civil Aviation (Amendment) Act, 1989, and shall be read and construed as one with the Civil Aviation Act, 1972, hereinafter referred to as "the principal Act".

2. Section 15A of the principal Act shall be amended as follows:—

(a) for the words "section 37C, subsection (1) of section 37D, sections 38, 39, 41, 42, 44, 45, 45A, 46, 47, 48 and 49 of the Merchant Shipping Act, 1973, in so far as they relate to the mortgage of a ship" there shall be substituted the words "sections 37A to 54A, both inclusive, of the Merchant Shipping Act, 1973, in so far as they relate to the mortgage of, or privilege over, a ship"; and

(b) immediately after the words "adaptations as may be necessary" there shall be inserted the words "including, but without prejudice to the generality of the foregoing, that wherever in the said sections of the said Act, reference is made to registrar and to ships, such reference shall be construed as a reference to the Director of Civil Aviation and to aircraft respectively".

3. The amendments effected to the principal Act by paragraph (b) of section 2 of this Act shall be deemed to have come into force on the coming into force of the Civil Aviation (Amendment) Act, 1979; and the amendment effected by paragraph (a) of the said section shall be

deemed to have come into force immediately after the coming into force of section 47 of the Merchant Shipping (Amendment) Act, 1988.
