**ACT No. XXXII of 1989**

*AN ACT to amend the Telemalta Corporation Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act XVI  
of 1975.

1. This Act may be cited as the Telemalta Corporation (Amendment) Act, 1989, and shall be read and construed as one with the Telemalta Corporation Act, 1975, hereinafter referred to as "the principal Act".

Substitution  
of section 35  
of the  
principal  
Act.

2. For section 35 of the principal Act there shall be substituted the following:

"Contracts  
of supply  
or works.

35. Except with the approval of the Minister granted for special reasons, Telemalta shall not enter into any contract for the supply of goods or materials, or for the execution of works, which is estimated by the Board to exceed in value the sum of ten thousand liri, or such sum as the House of Representatives may by resolution establish, unless after notice of the intention of the Corporation to enter into the contract has been published and competitive tenders have been issued."

Passed by the House of Representatives at Sitting No. 304 of the 13th November, 1989.
