L-għanijiet u raġunijiet ta' dan l-Abbozz huma biex jeliminaw il-klawżola *grandfather* li toħloq distinzjoni bejn l-applikanti li setgħu japplikaw fi żmien stabbilit bil-konsegwenza li jingħataw *warrant* u dawk l-applikanti li minhabba nuqqas ta' sigħat ta' Prattika li kienu meħtieġa f'dak iż-żmien, ma setgħux japplikaw fi żmien stabbilit.

**A BILL  
entitled**

*AN ACT to amend the Youth Work Profession Act, Cap. 533.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows:-

- Short title.           **1.** The short title of this Act is the Youth Work Profession (Amendment) Act, 2023 and this Act shall be read and construed as one with the Youth Work Profession Act, hereinafter referred to as "the principal Act".
- Cap. 533.
- Amendment of article 20 of the principal Act.       **2.** Sub-article (4) of article 20 of the principal Act shall be deleted.

**Objects and Reasons**

The objects and reasons of the Bill is to eliminate the grandfather clause which creates a distinction between those applicants who could have applied within the stipulated time-frame with the consequence of obtaining a warrant and those applicants who owing to the lack of practising hours required at the time, could not have applied within the stipulated time-frame.
