ACT No. VI of 1990

AN ACT to amend the Post Office Act, 1975.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Post Office (Amendment) Act, 1990, and shall be read and construed as one with the Post Office Act, 1975, hereinafter referred to as “the principal Act”.

Act XXXV of 1975.

Amendment of Second Schedule to the principal Act.

2. Immediately after subparagraph (b) of paragraph (4) of article 4 of the Second Schedule to the principal Act, there shall be added the following paragraph:

“(c) that he requires the printed matter in connection with such educational, professional, cultural or scientific activity being lawfully carried out by him, and that he shall not circulate such printed matter other than to persons carrying out a similar educational, professional, cultural or scientific activity and under a like condition not to circulate the same.”.
