## ABBOZZ TA' LIĠI msejjah

*ATT biex ikompli jemenda l-Att ta' l-1969 dwar l-Inbid.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1988 li jemenda l-Att dwar l-Inbid, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1969 dwar l-Inbid, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

L-Għan ta' l-Abbozz huwa li jnaqqas il-kwantità ta' għeneb frisk li għandu jiġi proċessat ta' kull sena minn persuni li jkollhom Liċenza Kummerċjali biex jipproduċu inbid minn 16,000 kilogramma għal 4,000 kilogramma.

*AN ACT further to amend the Wine Act, 1969.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.  
Act No. IX  
of 1969.

1. This Act may be cited as the Wine (Amendment) Act, 1988, and shall be read and construed as one with the Wine Act, 1969, hereinafter referred to as "the principal law".

2. For subsection (2) of section 6 of the principal Act there shall be substituted the following:

"(2) The holder of a Commercial Licence shall process annually not less than 4,000 kilogrammes of fresh grapes."

**Objects and Reasons**

The Object of this Bill is to reduce the quantity of fresh grapes that is to be processed annually by persons holding a Commercial Licence to produce wine from 16,000 kilogrammes to 4,000 kilogrammes.
