## ABBOZZ TA' LIĠI msejjah

*ATT biex ikompli jemenda L-Att ta' l-1975 dwar l-Uffiċċju tal-Posta.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1988 li jemenda l-Att dwar l-Uffiċċju tal-Posta, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1975 dwar l-Uffiċċju tal-Post, hawnhekk iżjed 'il quddiem msejjah "l-Att prinċipali".

Titolu fil-qosor u bidu fis-sehh Att XXXV ta' l-1975.

(2) Dan l-Att għandu jibda jsehh f'dik id-data li l-Ministru għall-Iżvilupp ta' l-Infrastruttura jista' jistabbilixxi b'avviz fil-Gazzetta.

2. L-artikolu 19 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

Emenda ta' l-artikolu 19 ta' l-Att prinċipali.

(a) is-subartikoli (5), (6) u (7) tiegħu għandhom jiġu enumerati mill-ġdid bħala s-subartikoli (6), (7) u (8) rispettivamente;

(b) minnufih wara s-subartikolu (4) tiegħu għandu jizdied dan is-subartikolu li ġej:

“(5) Il-postijiet l-oħrajn kollha għandhom ikunu mghammra b'kaxxa ta' l-ittri li tintlahaq mill-ewwel mit-triq.”;

u

(ċ) minflok in-nota marginali għal dan l-artikolu ghandu-  
jidhol dan li ġej:

“Postijiet ikunu mghammra b’kaxxi ta’ l-ittri, eċċ.”.

**A BILL**  
**entitled**

*AN ACT further to amend the Post Office Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Post Office (Amendment) Act, 1988 and shall be read and construed as one with the Post Office Act, 1975, hereinafter referred to as the "principal Act".

(2) This Act shall come into force on such date as the Minister for Development of Infrastructure may appoint by notice in the Gazette.

2. Section 19 of the principal Act shall be amended as follows:

(a) subsection (5), (6) and (7) thereof shall be renumbered as subsections (6), (7) and (8) thereof respectively;

(b) immediately after subsection (4) thereof there shall be added the following subsection:

"(5) All other premises shall be provided with a posting-slot immediately accessible from the street."; and

(c) for the marginal note thereto there shall be substituted the following:

“premises to be provided with letter boxes etc.”.

**Objects and Reasons**

The Bill provides that all premises shall be supplied with a letter-box or a posting-slot.
