“(1) Hlief bl-approvazzjoni tal-Ministru mogħtija għal raġunijiet speċjali, Enemalta ma għandha tidhol f'ebda kuntratt għall-provvista ta' oġġetti jew materjali, barra minn pitrolju, jew għall-eżekuzzjoni ta' xogħlijiet, fi jkun stmat mill-Bord li jkun jiswa iżjed mis-somma ta' għaxart elef lira, jew dik is-somma li l-Ministru bi ftehim mal-Ministru responsabbli għall-finanzi jista' minn żmien għal żmien jistabbilixxi b'Ordni fil-Gazzetta, kemm-il darba avviz tal-hsieb tal-Korporazzjoni li tagħmel il-kuntratt ma jkunx ġie pubblikat u nkunu harġu offerti kompetittivi.”

**A BILL
entitled**

AN ACT to amend the Enemalta Act, 1977.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act XVI
of 1977.

1. This Act may be cited as the Enemalta (Amendment) Act, 1989, and shall be read and construed as one with the Enemalta Act, 1977, hereinafter referred to as "the principal Act".

2. For subsection (1) of section 35 of the principal Act there shall be substituted the following:

"(1) 35. Except with the approval of the Minister granted for special reasons, Enemalta shall not enter into any contract for the supply of goods or materials, other than petroleum, or for the execution of works, which is estimated by the Board to exceed in value the sum of ten thousand liri, or such sum as the Minister with the concurrence of the Minister responsible for finance, may from time to time by Order in the Gazette establish, unless after notice of the intention of the Corporation to enter into the contract has been published and competitive tenders have been issued."

Objects and Reasons

The Object of the Bill is to increase the value of direct contracts which may be granted by Enemalta for the supply of goods or materials or for the execution of work, to a sum more consonant with today's values. The Bill also provides for the change of such values in the future.
