L-Għan ta' l-Abbozz huwa sabiex jagħti setgħa lill-Bord ta' l-Appelli dwar Stampat li jehles lil persuni li jkunu qegħdin iwettqu attività edukattiva, professjonali, kulturali jew xjentifika, u in konnessjoni ma' l-istess attività, ċertu stampat li kien ikun oġġezzjonabbli li kellu jinheles lill-pubbliku in generali.

**A BILL

AN ACT to amend the Post Office Act, 1975.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act XXXV
of 1975.

Amendment of
Second Schedule
to the
principal Act.

1. This Act may be cited as the Post Office (Amendment) Act, 1990, and shall be read and construed as one with the Post Office Act, 1975, hereinafter referred to as "the principal Act".

2. Immediately after subparagraph (b) of paragraph (4) of article 4 of the Second Schedule to the principal Act, there shall be added the following paragraph:

“(c) that he requires the printed matter in connection with such educational, professional, cultural or scientific activity being lawfully carried out by him, and that he shall not circulate such printed matter other than to persons carrying out a similar educational, professional, cultural or scientific activity and under a like condition not to circulate the same.”.

Objects and Reasons

The Object of the Bill is to empower the Printed Matter Appeals Board to release to persons carrying out an educational, professional, cultural or scientific activity, and in connection with the same, certain printed matter which would be objectionable if it were to be released to the general public.
