ABBOZZ TA' LIĠI msejjah

ATT biex jemenda l-Att ta' l-1988 biex jikkonsolida u jirrifirma l-liġi dwar l-Edukazzjoni f' Malta.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. Dan l-Att jista' jissejjah l-Att ta' l-1991 li jemenda l-Att dwar l-Edukazzjoni, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1988 dwar l-Edukazzjoni, hawnhekk aktar 'il quddiem imsejjah "l-Att prinċipali".

2. Is-subartikolu (10) ta' l-artikolu 28 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

(a) is-subartikolu preżenti għandu jiġi enumerat mill-ġdid bhala l-paragrafu (a) ta' l-istess subartikolu; u

(b) minnufih wara l-paragrafu (a) kif enumerat mill-ġdid, għandhom jidhlu dawn il-paragrafi godda li ġejjin:

“(b) L-elezzjoni għall-hatra ta' Rettur għandha ssir tliet xhur qabel eghluq it-terminu tal-kariga tar-Rettur, jew jekk għal xi raġuni tinholq vakanza, l-elezzjoni għandha ssir mhux aktar minn hmistax-il gurnata wara li tinholq dik il-vakanza.

(ċ) L-elezzjoni għandha ssir f'laqgħa tal-Kunsill msejjha għal dak l-iskop. Kull membru tal-Kunsill ikollu dritt jinnomina kandidat għall-kariga ta' Rettur. Jekk ikun hemm aktar minn żewġ kandidati, il-membri tal-

Kunsill ghandhom juru l-preferenza taghhom permezz ta' vot wiehed trasferibbli. Qabel ma ssir votazzjoni, il-Kunsill ghandu jiddetermina kif mehtieg id-dettalji procedurali ta' kif issir l-elezzjoni.”.

**A BILL
entitled**

AN ACT to amend the 1988 Act to consolidate and reform the law relating to Education in Malta.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Education (Amendment) Act, 1991, and shall be read and construed as one with the Education Act, 1988, hereinafter referred to as “the principal Act”.

2. Subsection (10) of section 28 of the principal Act shall be amended as follows:

(a) the present subsection shall be renumbered as paragraph (a) thereof; and

(b) immediately after paragraph (a) as renumbered, there shall be inserted the following new paragraphs:

“(b) The election for the office of Rector shall take place three months before the end of the term of office of the Rector or, should there be a vacancy for any reason, not later than fifteen days after the vacancy occurs.

(c) The election shall take place at a meeting of Council called for the purpose. Every member of Council shall have the right to nominate a candidate to the office of Rector. If there are more than two candidates, each member shall show his preference by

casting a single transferable vote. Prior to an election, the Council shall determine as required the procedural details relating to the method of election.”.

Objects and Reasons

The Object of the Bill is to regulate the method of election for the office of Rector of the University of Malta.
