*ATT biex ikompli jemenda l-Kodiċi Kriminali, Kap. 12.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1984 li jemenda l-Kodiċi Kriminali, u għandu jinqara u jiftiehem haġa waħda mal-Kodiċi Kriminali, hawnhekk iżjed 'il quddiem imsejjaħ "il-liġi prinċipali".

Emenda ta' l-artikolu 431 tal-liġi prinċipali.

2. Minnufih wara s-subartikolu (2) ta' l-artikolu 431 tal-liġi prinċipali għandu jidhrol il-proviso li ġej:

"Izda ma jkunx hemm il-htieġa li r-Registratur jinnota bil-miktub il-prezentata ta' l-attijiet tal-proċess."

### ACT No. I of 1984

*AN ACT further to amend the Criminal Code, Cap. 12.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Criminal Code (Amendment) Act, 1984, and shall be read and construed as one with the Criminal Code, hereinafter referred to as "the principal law". Short title.

2. Immediately after subsection (2) of section 431 of the principal law there shall be inserted the following proviso: Amendment of section 431 of the principal law.

"Provided that it shall not be a requirement for the Registrar to note down the filing of the record of the proceedings."

3. The provisions of section 2 of this Act shall also apply to applications of appeal filed prior to, and still pending on, the date of the coming into force of this Act. Transitory provision.
