ACT No. XX of 1985

AN ACT to amend the Code of Organization and Civil Procedure (Amendment) Act, 1985.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act No. XII
of 1985

1. This Act may be cited as the Act to amend the Code of Organization and Civil Procedure (Amendment) Act, 1985 and shall be read and construed as one with the Code of Organization and Civil Procedure (Amendment) Act, 1985, hereinafter referred to as “the principal Act”.

Amendment of
section 22 of the
principal Act.

2. In subsection (1) of section 871A of the principal law as added by section 22 of the principal Act the words “or against whose ship” shall be deleted.

Amendment of
section 25 of
the principal
Act.

3. In subsection (1) of section 25 of the principal Act for the words “by sections 9, 16 and 18” there shall be substituted the words “by sections 9, 16, 18 and 22”.
