ACT No. III of 1986

AN ACT further to amend the Guest Houses and Holiday Furnished Premises Act, 1974.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

(1) This Act may be cited as the Guest Houses and Holiday Furnished Premises (Amendment) Act, 1986, and shall be read and construed as one with the Guest Houses and Holiday Furnished Premises Act, 1974, hereinafter referred to as "the principal Act".</p> <p>(2) This Act shall come into force on such date as the Minister responsible for tourism may notice in the Gazette appointed.</p> | <p>Short title and commencement.</p> <p>Act No. XIV of 1974</p> |
| <p>2. Section 2 of the principal Act shall be amended as follows:</p> <p>(a) in the definition of "guest house" for the words "any hotel or lodging house" there shall be substituted the words "any hotel, hostel or lodging house";</p> <p>(b) immediately after the definition of "holiday premises keeper" there shall be added the following new definition: :</p> <p style="padding-left: 40px;">" "hostel" shall have the same meaning assigned to it by the Hotels and Catering Establishments Act, 1967;";</p> <p>(c) in the definition of "house" immediately after the words "a hotel," there shall be inserted the words "a hostel,"; and</p> <p>(d) in the definition of "lodging house" immediately after the words "or a guest house" there shall be inserted the words " or a hostel".</p> | <p>Amendment of section 2 of the principal Act.</p> |
| <p>3. Section 5 of the principal Act shall be amended as follows:</p> <p>(a) in subsection (3) thereof for the words "National Tourist Organisation" there shall be substituted the words "National Tourism Organisation"; and</p> | <p>Amendment of section 5 of the principal Act.</p> |

(b) for subsection (4) thereof there shall be substituted the following:

Act XXI of 1984

“(4) For the purposes of this section “National Tourism Organisation” means the organisation set up under that name by the National Tourism Organisation Act, 1984.”.

Amendment of section 11A of the principal Act.

4. Section 11A of the principal Act shall be amended as follows:

(a) in subsection (5) thereof for the words “National Tourist Organisation” there shall be substituted the words “National Tourism Organisation”; and

(b) for subsection (6) thereof there shall be substituted the following:

“(6) For the purposes of this section “National Tourism Organisation” means the organisation set up under that name by the National Tourism Organisation Act, 1984.”.

Addition of new section 16 to the principal Act.

5. Immediately after section 15 of the principal Act there shall be added the following new section:

“Probation of Offenders Act, 1957, shall not apply. Act XII of 1957
16. The provisions of the Probation of Offenders Act, 1957 shall not apply in relation to the offences under sections 4, 5, 10 and 11A of this Act and in relation to any breach of any regulation made under section 12 of this Act.”.
