ACT No. IX of 1986

AN ACT further to amend the Import Duties Act, 1976.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Import Duties (Amendment) Act, 1986, and shall be read and construed as one with the Import Duties Act, 1976, hereinafter referred to as “the principal Act”.

(2) The amendments effected by this Act to sub-heading (A) of heading 85.15 of the First Schedule shall be deemed to have come into force on the 2nd day of December, 1985, and the other amendments, namely those to sub-heading (C) of heading 85.15 and the amendments to headings 92.11 and 85.14 shall be deemed to have come into force on the 4th day of February, 1986.

2. The First Schedule to the principal Act shall be amended as follows:

(a) in heading 85.14, for the figures “90” and “85” shown in the Second Column and in the Third Column, there shall be respectively inserted the figures “72” and “67”;

(b) (i) for sub-heading (A) of heading 85.15 and for the figures in respect thereof in the Second and Third Columns there shall be substituted respectively the sub-heading shown in the First Column

and the relative figures shown in the Second and Third Columns hereunder:

“(A) Transmission, reception apparatus, and television cameras used in radio, television, telegraph and telephone stations:		
(1) Cordless telephones	72	67
(2) Other	0	0”;

(ii) for sub-heading (C) of the same heading 85.15 and the relative figures thereto in the Second Column and in the Third Column there shall be respectively inserted the heading shown in the First Column and the relative figures shown in the Second and in the Third Columns hereunder:

“(C) Other	72	67”;

(c) for the heading 92.11 and for the figures in respect thereof in the Second and Third Columns there shall be substituted respectively the heading shown in the First Column and the relative figures shown in the Second and Third Columns hereunder:

“92.11 Gramophones, dictating machines and other sound recorders and reporducers, including record-players and tape decks with or without sound-heads; television image and sound recorders and reporducers, magnetic.	72	67”.
