311A. Ebda persuna ma tista', mingħajr liċenza tal-Pulizija, ikollha fil-pussess jew taħt il-kontroll tagħha xi *video recorder*, sew jekk ikollu inkorporat miegħu *camera* sew jekk le.

311B. (1) Mal-ħruġ jew mat-tiġdid ta' liċenza skond l-artikolu 311A ta' dan il-Kodiċi u meta r-regolamenti taħt dan l-artikolu hekk jipprovdu, u f'dawk iż-żminijiet wara kif jista' jiġi preskritt bir-regolamenti magħmula mill-Ministru responsabbli għat-telegrafija mingħajr filj għandu jithallas mill-persuna li tapplika għal dak il-ħruġ jew tiġdid dritt kif jista' jiġi preskritt taħt dawk ir-regolamenti, u jistgħu jsiru dispozizzjonijiet differenti f'dawk ir-regolamenti dwar liċenzi differenti, skond ix-xorta, kondizzjonijiet, limitazzjoni u terminu tagħhom.

(2) Bla hsara għad-dispożizzjonijiet tas-subartikolu (1) ta' dan l-artikolu, il-Ministru responsabbli għat-telegrafija minghajr fili jista' jagħmel regolamenti sabiex jitwettqu aħjar id-dispożizzjonijiet ta' dan l-artikolu u, b'mod partikolari —

(a) sabiex jippreskrivu l-avviż li għandu jingħata minn dawk il-persuni kif jista' jiġi msemmi fir-regolamenti dwar il-manifattura, importazzjoni, bejgħ, kiri jew disponiment ieħor ta' *video recorders*, u

(b) sabiex jipprovdu li xi waħda jew kull waħda mid-dispożizzjonijiet tar-regolamenti japplikaw għal kull apparat jew tagħmir li jista' jkun użat in konnessjoni ma' *video recorders*.”.

### ACT No. XIV of 1986

*AN ACT further to amend the Code of Police Laws, Cap. 13.*

**BE IT ENACTED** by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Code of Police Laws (Amendment) Act, 1986, and shall be read and construed as one with the Code of Police Laws, hereinafter referred to as the “principal law”. Short Title.

2. Immediately after Part XXIII of the principal law there shall be added the following: Addition of  
new Part  
XXIII A to the  
principal law.

#### “PART XXIII A

#### Of Video Recorders

Video recorder licence. 311A. No person shall, without a licence from the Police have in his possession or under his control any video recorder, whether incorporating a camera or not.

Licence fee and power to make regulations. 311B. (1) On the issue or renewal of a licence in terms of section 311A of this Code and where the regulations under this section so provide, at such times thereafter as may be prescribed by the regulations made by the Minister responsible for wireless telegraphy, there shall be paid by the person applying for such issue or renewal a fee as may be prescribed under those regulations, and different provisions may be made in those regulations in relation to different licences, according to the nature, conditions, limitation and duration thereof.

(2) Without prejudice to the provisions of subsection (1) of this section, the Minister responsible for wireless telegraphy may make regulations for the better carrying out of the provisions of this section and, in particular —

(a) for prescribing the notice which shall be given by such persons as may be designated in the regulations of the manufacture, importation, sale, hire or other disposal of video recorders, and

(b) for providing that any or all of the provisions of the regulations shall apply to any apparatus or equipment that may be used in connection with video recorders.”.
