ACT No, XX of 1986

AN ACT further to amend, the National Assistance Act, 1956.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

Act VIII of

1. This Act may be cited as the National Assistance (Amendment) Act, 1986, and shall be read and construed as one with the National Assistance Act, 1956, hereinafter referred to as “the principal law”.

2. Subsection (2) of section 12 of the principal Act, shall be deleted.
