ACT No. XXXVII of 2023

AN ACT to further amend the Code of Organization and Civil Procedure, Cap. 12.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Code of Organization and Civil Procedure (Amendment No. 2) Act, 2023 and this Act shall be read and construed as one with the Code of Organization and Civil Procedure, hereinafter referred to as "the Code".

Short title.

Cap. 12.

2. In sub-article (1) of article 29 of the Code, immediately after the words "the Attorney General," there shall be added the words "the State Advocate,".
