## ABBOZZ TA' LIĠI

### msejjah

*ATT biex ikompli jemenda l-Kodiċi tal-Liġijiet tal-Pulizija, Kap. 13.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1977 li jemenda l-Kodiċi tal-Liġijiet tal-Pulizija, u għandu jinqara u jftiehem haġa waħda mal-Kodiċi tal-Liġijiet tal-Pulizija, hawnhekk iżjed 'il quddiem imsejha "il-liġi prinċipali".

Zieda ta' artikolu ġdid 290A mal-liġi prinċipali.

2. Minnufih wara l-artikolu 290 tal-liġi prinċipali għandu jizdied l-artikolu ġdid li ġej:

"Faċilitajiet 290A. (1) Kull dgħajsa ta' l-istim għall-passiġġieri li sanitarji taħdem jew maħsuba li taħdem, bejn portijiet f'dawn il-fuq Gżejjer għandha tkun provduta b'loki mgħammar kif imiess dghajjes ta' b'sistema ta' *flushing* xieraq u b'faċilitajiet xierqa għall-ħasil ta' l-idejn, f'kull każ għas-sodisfazzjon tas-Suprintendent tas-Saħħa Pubblika.

(2) Is-sid ta' kull dgħajsa ta' l-istim bħal dik għandu jiehu ħsieb li dak il-loki u tagħmir relattiv jinżammu dejjem jaħdmu u fi stat tajjeb ta' tiswija u għandu jiżgura li kull parti tad-dgħajsa ta' l-istim tinżamm f'kondizzjoni sanitarja u iġjenika tajba."

Emenda ta' l-artikolu 314 tal-liġi prinċipali.

3. Fis-subartikolu (1C) ta' l-artikolu 314 tal-liġi prinċipali, minnufih wara l-kliem "ta' l-artikolu 85" għandhom jidhlu l-kliem "jew ta' l-artikolu 290A".

L-Għan ta' dan l-Abbozz huwa li jemenda l-Kodiċi tal-Liġijiet tal-Pulizija sabiex jiġu żgurati kondizzjonijiet sanitarji u iġjenici tajbin fuq dghajjes ta' l-istim għall-passiġġieri li jaħdmu bejn portijiet f'dawn il-Gżejjer.

**A BILL**  
**entitled**

*AN ACT further to amend the Code of Police Laws, Cap. 13.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Code of Police Laws (Amendment) Act, 1977, and shall be read and construed as one with the Code of Police Laws, hereinafter referred to as "the principal law".

Short title.

2. Immediately after section 290 of the principal law there shall be added the following new section:

Addition of new section 290A to the principal law.

"Sanitary facilities on steamboats.

290A. (1) Every passenger steam-boat plying, or intended to ply, between harbours in these Islands shall be provided with a privy duly equipped with a suitable flushing system and with adequate hand washing facilities, in either case to the satisfaction of the Superintendent of Public Health.

(2) The owner of any such steam-boat shall cause such privy and relative equipment to be kept functional and in good state of repair at all times and shall ensure that every part of the steam-boat is constantly kept in good sanitary and hygienic condition."

3. In subsection (1C) of section 314 of the principal law, immediately after the words "of section 85" there shall be inserted the words "or of section 290A".

Amendment of section 314 of the principal law.

**Objects and Reasons**

The Object of this Bill is to amend the Code of Police Laws so as to ensure good sanitary and hygienic conditions on passenger steam-boats plying between harbours in these Islands.
