*ATT biex ikompli jemenda l-Att ta' l-1957 dwar il-Hinijiet tax-Xoghol tal-Hwienet u tal-Bejjiegha fit-Toroq.*

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parliament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1977 li jemenda l-Att dwar il-Hinijiet tax-Xoghol tal-Hwienet u tal-Bejjiegha fit-Toroq, u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1957 dwar il-Hinijiet tax-Xoghol tal-Hwienet u tal-Bejjiegha fit-Toroq, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Sostituzzjoni ta' l-artikolu 6B ta' l-Att prinċipali.

2. Minflok l-artikolu 6B ta' l-Att prinċipali għandu jidhol dan li ġej:

"Kjoskijiet ta' petrol. 6B. (1) Kull kjosk tal-petrol għandu jkun magħluq għall-qadi tal-parručani —

(i) nhar ta' Hadd u btajjel pubbliċi ohra, u

(ii) mhux iktar tard mit-8 p.m. f'kull ġurnata ohra matul il-perijodu bejn l-1 ta' Ottubru ta' kull sena u l-31 ta' Mejju tas-sena ta' wara u mhux aktar tard mid-9 p.m. f'kull ġurnata bħal dik matul il-perijodu bejn l-1 ta' Ġunju u t-30 ta' Settembru ta' kull sena, f'kull każ iż-żewġ dati inkluzi,

u ma jithalla li jsir ebda qadi ta' parručani qabel il-5 a.m. tal-ġurnata ta' wara:

Iżda, f'kull wiehed mid-distretti hekk kif speċifikati fit-Tieni Skeda li tinsab ma' dan l-Att, żewġ kjoskijiet tal-petrol, skond roster ippreparat minn żmien għal żmien mid-Direttur tax-Xoghol u Emigrazzjoni, għandhom jibqgħu miftuhin għall-qadi ta' parručani sa nofs inhar fil-Hdud, u fil-btajjel pubbliċi l-ohra:

Iżda wkoll, il-persuna inkarigata minn kull kjosk tal-*petrol* li ma jkollhiex permess li tiftah f'xi Hadd, jew fi btala pubblika oħra skond id-disposizzjonijiet ta' dan is-subartikolu għandha tiehu hsieb li jitwaha ma' dak il-kjosk avvż li jkun jidher sewwa minn barra li juri l-isem u l-indirizz tal-kjoskijiet tal-*petrol* li jkollhom jinżammu miftuha fl-istess distrett fejn ikun qiegħed l-imsemmi kjosk.

(2) Il-Ministru responsabbli għax-xogħol jista', minn żmien għal żmien, b'ordni jemenda t-Tieni Skeda li tinsab ma' dan l-Att."

4. Minflok l-intestatura "SKEDA" minnufih wara l-artikolu 13 ta' l-Att prinċipali għandha tidhol l-intestatura "L-EWWEL SKEDA".

5. Minnufih wara l-Ewwel Skeda li tinsab ma' l-Att prinċipali għandha tizzied l-Iskeda ġdida li ġejja:

#### Għanijiet u Raġunijiet

L-Għan ta' dan l-Abbozz huwa li jemenda l-Att ta' l-1957 dwar il-Hwienet tax-Xogħol u tal-Bejjeġha fit-Toroq sabiex, nhar ta' Hadd, u btajjel pubbliċi oħra, numru limitat biss ta' kjoskijiet tal-*petrol* jifthu għax-xogħol fuq sistema ta' roster.

**A BILL**

**entitled**

*AN ACT further to amend the Shops and Hawkers (Business Hours) Act, 1957.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Shops and Hawkers (Business Hours) (Amendment) Act, 1977, and shall be read and construed as one with the Shops and Hawkers (Business Hours) Act, 1957, hereinafter referred to as "the principal Act".

Substitution of section 6B of the principal Act.

2. For section 6B of the principal Act there shall be substituted the following:

"Petrol kiosks.

6B. (1) Every petrol kiosk shall be closed for the serving of customers—

- (i) on Sundays and other public holidays, and
- (ii) not later than 8 p.m. on any other day during the period from the 1st day of October of any year to the 31st day of May of the next succeeding year and not later than 9 p.m. on any such day during the period from the 1st day of June to the 30th day of September of any year, in either case both days included,

and no serving of customers shall be permitted before 5 a.m. of the next following day:

Provided that, in each of such districts as are specified in the Second Schedule to this Act, two petrol kiosks, in accordance with a roster prepared from time to time by the Director of Labour and Emigration, shall remain open for the serving of customers up to 12 noon on Sundays and other public holidays:

Provided further that, the person in charge of any petrol kiosk not allowed to be open on any Sunday or on another public holiday in accordance with the provisions of this subsection shall cause to be affixed to the said kiosk a notice clearly visible from the outside showing the name and address of the petrol kiosks which are required to be kept open in the same district in which the said kiosk is situated.

(2) The Minister responsible for labour may, from time to time, by order amend the Second Schedule to this Act.”.

3. For the words “of the Schedule” in subsection (1) of section 12 of the principal Act there shall be substituted the words “of the First Schedule”.

Amendment of section 12 of the principal Act.

4. For the heading “SCHEDULE” immediately after section 13 of the principal Act there shall be substituted the heading “FIRST SCHEDULE”.

Amendment of Schedule to the principal Act.

5. Immediately after the First Schedule to the principal Act there shall be added the following new Schedule:

Addition of new Schedule to the principal Act.

#### Objects and Reasons

The Object of this Bill is to amend the Shops and Hawkers (Business Hours) Act, 1957, so that, on Sundays and other public holidays, a limited number of petrol kiosks only shall be open for business on a roster system.
