The Special Representative will be in Malta on 17-18 October to address the Malta Workshops as well as to lead a workshop on supply chains with Maltese stakeholders, and he would be leaving on 18th October in the afternoon (flight is at 14:20hrs).

If I recall correctly, Parliament usually convenes in the afternoon, nevertheless, if in case it convenes in the morning, one may wish to consider organising a briefing with the whole Chamber on the 18th.

If it is convened in the afternoon, then one may wish to consider organising meetings on 18th in the morning with some of the committees such as those dealing with migration, human rights and economic issues.

As you are aware, Valiant Richey, OSCE Special Representative on Combating Trafficking in Human Beings will travel to Malta on 17-18 October 2022 to address the Malta Workshops and to lead a table top exercise with the relevant supply chains stakeholders.

In the margins of the visit, Mr Richey has expressed his willingness to address parliamentarians. His rationale is that the scourge of trafficking is cross-cutting and affects all Ministries and the whole of society, reason why he always finds it useful to address the representatives of the electorate. His briefing about the subject could last about 60-90 minutes. We could either decide the he addresses the entire chamber, or else a few relevant committees such as those on migration, human rights and economic issues.

I understand that parliament convenes on Tuesdays, which means a time slot could be found on Tuesday, 18 October.

I fully endorse his proposal and strongly advise that a time slot will be found for him to address the parliamentarians as ultimately they will be the ones to discuss and endorse pertinent legislation related to the imminent EU Directive on supply chains and other related pertinent issues.
