ATT biex ikompli jemenda l-Ordinanza dwar ir-Regulament tat-Traffiku, Kap. 105.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, ħareġ b'liġi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjah l-Att ta' l-1976 li jemenda l-Ordinanza dwar ir-Regulament tat-Traffiku, u għandu jinqara u jiftiehem haġa waħda ma' l-Ordinanza dwar ir-Regulament tat-Traffiku, hawnhekk iżjed 'il quddiem imsejha "il-liġi prinċipali".

Zieda ta' artikolu ġdid 11A mal-liġi prinċipali.

2. Minnufih wara l-artikolu 11 tal-liġi prinċipali għandu jiżdied l-artikolu ġdid li ġej:

"Projbiz-
zjoni ta'
tipjip fuq
karozzi
tal-linja.

11A. (1) Ebda persuna ma għandha, fil-waqt li tkun ġo jew fuq xi *motor omnibus* li tkun qed tistenna biex ittel-
la' passigġieri jew tkun qegħda fuq xi linja, tpejjep xi tabakk.

(2) Ikun id-dmir tal-kunduttur ta' kull *motor omnibus* bħal dik li jara li d-disposizzjoni tas-subartikolu (1) ta' dan l-artikolu tkun qed tiġi mharsa."

Zieda ta' artikolu ġdid 17B mal-liġi prinċipali.

3. Minnufih wara l-artikolu 17A tal-liġi prinċipali għandu jiżdied l-artikolu ġdid li ġej:

"Reati
kontra

11A.

17B. Kull persuna li tikser xi wahda mid-disposizzjo-
nijiet ta' l-artikolu 11A ta' din l-Ordinanza tkun hatja ta'
reat u tehel —

(a) meta tinsab hatja l-ewwel darba, multa ta' mhux inqas minn żewġ liri, u

(b) meta tinsab hatja t-tieni darba u wara, multa ta' mhux inqas minn hames liri.”.

A BILL

entitled

AN ACT further to amend the Traffic Regulation Ordinance, Cap. 105.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Traffic Regulation (Amendment) Act, 1976, and shall be read and construed as one with the Traffic Regulation Ordinance, hereinafter referred to as “the principal law”.

Addition of new section 11A to the principal law.

2. Immediately after section 11 of the principal law there shall be added the following new section:

“Prohibition of smoking on route motor omnibuses. 11A. (1) No person shall, while he is in or on any motor omnibus which is waiting to pick up passengers or plying on any route, smoke any tobacco.

(2) It shall be the duty of the conductor of any such motor omnibus to see that the provision of subsection (1) of this section is complied with.”

Addition of new section 17B to the principal law.

3. Immediately after section 17A of the principal law there shall be added the following new section:

“Offences against section 11A. 17B. Any person who contravenes any of the provisions of section 11A of this Ordinance shall be guilty of an offence and shall be liable —

(a) on a first conviction, to a fine (*multa*) of not less than two pounds, and

(b) on a second or subsequent conviction, to a fine (*multa*) of not less than five pounds.”.

Objects and Reasons

The Object of this Bill is to prohibit tobacco smoking on route motor omnibuses.
